

# Programme Requirements / Qualification Profile of the Graduate

The programme is structured into 2 semesters of course work and 1 semester for the Master thesis.



The Master of Arts in Communication Design "Design, Future, Society" stands out for its specific orientation towards the professional market and its strong international orientation.

On completion of the programme, students should have provided evidence of being able to:

- Demonstrate detailed knowledge relevant to trans-media design and integrated communication in relation to social interaction and demonstrate a sophisticated understanding of theories, concepts, information and techniques at the forefront of the discipline;
- Exhibit mastery in the exercise of generic and subject-specific intellectual abilities necessary for effective interactive engagement within a trans-media environment;
- Demonstrate a comprehensive understanding of relevant techniques and methodologies applicable to their own research or advanced scholarship;
- Take a proactive and self-reflective role in developing professional relationships with others and perform sensitively and productively in a mixed cultural and multidisciplinary setting;
- Proactively identify need, propose strategic solutions, formulate ideas and frame specific research questions;
- Develop detailed research design for investigation and successfully complete the investigation through to implementation and evaluation;
- Critically and creatively evaluate current issues, research and advanced scholarship in the discipline and possess the ability to undertake analysis and synthesis of complex casework.
- Demonstrate an understanding of innovative technologies within the field of communication processes whilst developing new approaches to utilise these technologies;
- Develop an ability to self-direct research into innovative new technologies/techniques and demonstrate an ability to reflect and formulate findings on experimental work.

Teaching in this programme aims to convey to the students a combination of theoretical knowledge and practical experience. The students acquire the knowledge base, professional awareness, critical faculty, interpretative and communicative skills and ethical responsibility expected from professionals working within specialist areas.

# **Programme Components and Details**

### Grading Scheme

Grading system: 1.0 - 1.2 (distinction); 1.3 - 1.5 (very good); 1.6 - 2.5 (good); 2.6 - 3.5 (satisfactory); 3.6 - 4.0 (sufficient); 4.1 - 5.0 (fail).

### **Overall Classification**

The overall classification is shown on the *Master-Zeugnis*. It is based on assessments every semester and a Master thesis.

The course grades and the Master thesis are weighted to calculate the final grade.

The degree corresponds to the second cycle degree according to the new European Higher Education System (Bologna Declaration) and qualifies the holder to apply for a third cycle degree.

#### 8. INFORMATION ON THE GERMAN HIGHER EDUCATION SYSTEM

#### 8.1 Types of Institutions and Institutional Status

Higher education (HE) studies in Germany are offered at three types of Higher Education Institutions (HEI).<sup>2</sup>

 Universities (Universities) including various specialized institutions, offer the whole range of academic disciplines. In the German Iradition, universities focus in particular on basic research so that advanced stages of study have mainly theoretical orientation and research-oriented components.

 Fachhochachulen (Universities of Applied Sciences) concentrate their study programmes in engineering and other technical disciplines, business-related studies, social work, and design areas. The common mission of applied research and development implies a distinct application-oriented focus and professional character of studies, which include integrated and supervised work assignments in industry, enterprises or other relevant institutions.

 Kunst- and Musikhochschalen (Universities of ArtMusic) offer studies for artistic careers in fine arts, performing arts and music; in such fields as directing, production, writing in theatre, film, and other media; and in a variety of design areas, architecture, media and communication.

Higher Education Institutions are either state or state-recognized institutions. In their operations, including the organization of studies and the designation and award of degrees. They are both subject to higher education legislation.

8.2 Types of Programmes and Degrees Awarded

Studies in all three types of institutions have traditionally been offered in integrated "long" (one-tier) programmos leading to Diplom- or Magister Artitum degrees or completed by a Staatspriftung (State Examination).

Within the framework of the Bologna-Process one-lier study programmes are successively being replaced by a two-lier study system. Since 1930, a scheme of first- and second-level degree programmes (Bachelor and Master) was introduced to be offered parallel to cristead of integrated "long" programmes. These programmes are designed to provide enlarged variety and flexibility to students in planning and pursuing educational objectives, they also enhance international compatibility of studies.


The German Qualification Framework for Higher Education Degrees<sup>1</sup> describes the degrees of the German Higher Education System. It contains the classification of the qualification levels as well as the resulting qualifications and competencies of the graduates.

For details cf. Soc. 8.4.1, 8.4.2, and 8.4.3 respectively. Table 1 provides a synoptic summary.

#### 8.3 Approval/Accreditation of Programmes and Degrees

To ensure quality and comparability of qualifications, the organization of studies and general degree requirements have to conform to principles and regulations established by the Standing Conference of the Ministers of Education and Cultural Affairs of the Länder in the Federal Republic of Germany (KMK).<sup>4</sup> In 1939, a system of accreditation for programmes of study has become operational under the control of an Accreditation Council at national level. All new programmes have to be accredited under this scheme; after a successful accreditation they receive the quality-label of the Accreditation Council.<sup>5</sup>

#### 8.4 Organization and Structure of Studies

The following programmes apply to all three types of institutions. Bachelor's and Master's study courses may be studied consecutively, at various higher education institutions, at different types of higher education institutions and with phases of professional work between the first and the second qualification. The organization of the study programmes makes use of modular components and of the European Credit Transfer and Accumulation System (ECTS) with 30 credits corresponding to one semester.

#### 2.4.1 Bachelor

Bachelor degree study programmes lay the academic foundations, provide methodological skills and lead to qualifications related to the professional field. The Bachelor degree is awarded after 3 to 4 years. The Bachelor degree programme includes a thesis requirement. Study courses leading to the Bachelor degree must be accredited according to the Law exhibition a Security for the According to Church

Courses leading to the cachelor degree must be accredited according to the Law establishing a Foundation for the Accreditation of Study Programmes in Germany.<sup>9</sup> First degree programmes (Bachelor) lead to Bachelor of Arts (B.A.), Bachelor of Science (B.Sc.), Bachelor of Engineering (B.Eng.), Bachelor of Laws (LL.B.), Bachelor of Fine Arts (B.F.A.), Bachelor of Music (B.Mus.) or Bachelor of Education (B.Ed.).

#### 8.4.2 Master

Master is the second degree after another 1 to 2 years. Master study programmes may be differentiated by the profile types "practice-oriented" and "research-oriented". Higher Education Institutions define the profile. The Master degree study programme includes a thesis requirement

Study programmes leading to the Master degree must be accredited according to the Law establishing a Foundation for the Accreditation of

Study Programmes in Germany.' Study Programmes in Germany.' Second degree programmes (Master) lead to Master of Arts (M.A.), Master of Science (M.Sc.), Master of Engineering (M.Eng.), Master of Laws (L.L.M), Master of Fine Arts (M.F.A.), Master of Music (M.Mus.) or Master of Education (M.Ed.). Master study programmes, which are designed for continuing education, may carry other designations (e.g. MBA).

# 8.4.3 Integrated "Long" Programmes (One-Tier): Diplom degrees, Magister Artian, Staatsprüfung

An integrated study programme is either mono-disciplinary (Diplom An integrated study programme is either mono-disciplinary (Dplom degrees, most programmes completed by a Staatsprüfung) or comprises a combination of either two major or one major and two minor fields (Magister Artion). The first stage (1.5 to 2 years) focuses on broad orientations and foundations of the field(s) of study. An intermediate Examination (Dplom-Verprüfung for Dplom degrees; 2wischenprüfung or credit requirements for the Aligister Arthory is prerequitite to enter the second stage of advanced studies and specializations. Degree requirements include submission of a thesis (up to 6 months duration) and comprehensive final written and onal examinations. Similar regulations apoly to studies taking to a Staattonifung. The level of regulations apply to studies leading to a Staatsprütung. The level of qualification is equivalent to the Master level.

 Integrated studies at Universitätee (U) last 4 to 5 years (Diptem degree, Magister Askum) or 3 to 6.5 years (Staatsprifung). The Diptem degree is awarded in engineering disciplines, the natural sciences as well as economics and business. In the humanities, the corresponding degree is usually the Magister Askum (M.A.), in the social sciences, the practice varies as a matter of institutional traditions. Studies preparing for the legal, medical and pharmaceutical professions are completed by a Staatsprüfung. This applies also to studies preparing for teaching professions of some Länder.

professions of some Lander. The three qualifications (Diplom, Magister Artium and Staatsprüfung) are academically equivalent. They qualify to apply for admission to doctoral studies. Further prerequisites for admission may be defined by the Higher Education Institution, cf. Sec. 8.5.

integrated studies at Fachtochschulen (FH)/Universities of Applied Sciences (UAS) last 4 years and lead to a Diptom (FN) degree. While the FMUAS are non-declorate granting institutions, qualified graduates may apply for admission to doctoral studies at doctorate-granting institutions, cf. Sec. 0.5.

- Studies at Kunst- and Mozikhochschulen (Universities of Art/Music etc.) are more diverse in their organization, depending on the field and individual objectives. In addition to Djokon/Nagister degrees, the integrated study programme awards include Certificates and certified examinations for specialized areas and professional purposes.

#### 8.5 Doctorate

Universities as well as specialized institutions of university standing and some Universities of Art/Music are doctorate-granting institutions. Formal prerequisite for admission to doctoral work is a qualified Master (UAS prerequisive for admission to declorar work is a qualmed waster (UKs) and U), a Magister degree, a Diplom, a Staatsprüfung, or a foreign equivalent. Particularly qualified holders of a Bachelor or a Diplom (FH) degree may also be admitted to doctoral studies without acquisition of a further degree by means of a procedure to determine their aptitude. The universities respectively the doctorate-granting institutions regulate entry to a doctorate as well as the structure of the procedure to determine aptitude. Admission further requires the acceptance of the Dissertation research project by a professor as a supervisor.

### 8.6 Grading Scheme

The grading scheme in Germany usually comprises five levels (with numerical equivalents; intermediate grades may be given); "Sehr Guf" (1) = Very Geod: "Guf" (2) = Geod: "Behriedgend" (3) = Satisfactory; "Ausreichend" (4) = Sufficient; "Wicht ausreichend" (5) = Non-Sufficient/Fail. The minimum passing grade is "Ausreichend" (4). Verbal designations of grades may vary in some cases and for doctoral descent degrees. In addition institutions partly already use an ECTS grading scheme.

### 8.7 Access to Higher Education

The General Higher Education Entrance Qualification (Algemeire Hochschulterfe, Abitur) after 12 to 13 years of schooling allows for admission to all higher educational studies. Specialized variants (Fachgebundende Hochschulreife) allow for admission to particular disciplines. Access to Fachhochschulen (UAS) is also possible with a Fachtochactolrefe, which can usually be acquired after 12 years of schooling. Admission to Universities of ArtMusic may be based on other or require additional evidence demonstrating individual aptitude. Higher Education institutions may in certain cases apply additional admission procedures.
